

# Greetings from the Washington State Urology Society!

This is your Urology Society news update.

## Advocacy

It has been a busy rule-making period. The following are relevant to Urology:

- 1. The Washington State legislative session ends soon. House Bill 1357 standardizes prior authorization by shortening times to determinations, and mandating electronic prior authorization, with integration into EMR. This has passed in the State House and is awaiting a vote in the Senate.
- 2. Cigna is requiring submission of medical records with all E+M claims for CPT 99212-99215 and modifier -25, when a minor procedure is billed. This is scheduled to go into effect May 25. Many organizations, including AMA and WSMA, have stated their opposition.
- 3. Naturopathic Practitioners requested the expansion of their scope of practice to include vasectomies. WSUS Government Affairs Chair Dr. Jeffrey Frankel personally attended 3 Board of Naturopathy meetings to testify against this, and WSUS and AUA submitted a joint letter in opposition. The Washington State Attorney General submitted an opinion to the Board of Naturopathy which did not increase their scope of practice to include vasectomy but did not specifically oppose it either.

We encourage you to contact your state Senators and Representatives, and

voice your concerns about these and other issues. The impact of a personal relationship with your legislators cannot be overstated. WSUS also invites the membership to submit any advocacy questions or concerns.
